# **Meeting Minutes**

## **Introductions:**

Ms. Thayer: Welcomed everyone – both in person and on Teams.

Beya Thayer introduced new team members: Linn Montjoy – Inmate Services Program Manager, Heidi Howard – YJMHC Public Affair Officer, and Sabath Oliver – Connection Center Program Manager.

#### Welcome:

**Chief Newnum**: Thank you to the Coalition and partnership with new Criminal Justice Center (CJC), opening on Monday, we are very excited. There will be a phased opening approach due to manpower issues. Reach Out started in 2016. All studies showing that recidivism has gone down with our Reach-Out program. We could not have done this without the Coalition. The Connection Center at the new CJC wouldn't be possible without our partners. A portion of the Connection Center will also serve as inpatient treatment for Title 36 evaluations through Polara, which will streamline process for law enforcement partners and the Jail.

## **Coalition Updates:**

Yavapai Criminal Justice Center Update: Chief Newnum, YCSO / Commander Kimbriel, YCSO

- Phased opening due to high vacancy rate of officers. Phase 1 begins Monday, July 17<sup>th</sup> (includes Courts) with Intake as the same model as current Prescott facility (no persons who are combative and no medical issues).
- Phase 2 Infirmary (full-service Intake) (hoping to be here as soon as possible)
- Phase 3, 4 and 5 Encompass opening housing units and kitchen facilities.
- The CJC is not long-term holding like Camp Verde is, it is just a transition jail. This facility will be for individuals pre-EDC (Early Disposition Court). Verde will always be main jail, main housing, and biggest population.
- YCSO is currently working with an architect to remodel the Camp Verde Jail to add a Connection Center in that location as well.

#### **Connections Center Processes:**

#### • Re-entry:

Sabath Oliver with Yavapai County Health Services is managing the re-entry section. Individuals leaving both the jail and the title 36 operations will be able to use the services within the re-entry center.

Clothing donations needed for the clothes closet for released individuals. Sabath will email the list to everyone. Harm reduction donation items are needed as well.

Office spaces within the re-entry center can be used by any service provider as they are assisting people.

## • Title 36- Polara:

The inpatient portion of the Connection Center in which Polara Health will conduct Title 36 Court Ordered Evaluations is hoping to open October 1<sup>st</sup>.
